Funding would be based on the prior year enrollment but will include all day kindergarteners at 1 FTE. Budget check form was reviewed. Legislators are working on changing laws for KPERS working after retirement to no surcharge for retirees if earnings are below \$25,000; Due Process for teachers; and tax laws. Memorandum of Understanding with local law enforcement will again need to be done before July 1st.
