John Crist presented the AD Report. State Track Results; 4x800 relay finished 5th at state, Sarah Bird was 4th in 800, 11th in 1600 and 10th in long jump. Evie Gruenbacher was 12th in triple jump. Leoti was denied acceptance into the NWKL at the last league meeting. Recommendation to continue the Cross Country cooperative agreement with Wheatland-Grinnell as approved in April of 2017. High jump pit needs to be replaced. Summer weightlifting numbers are 23-25 kids each day and at least 41 different kids. Fall sports meeting on August 10th will show a concussion video to parents and athletes and a baseline concussion test will be administered by doctors from Bluestem Medical. School finance bill has been approved by Legislators and awaits Governor's signature and then will need to be approved by the Kansas Supreme Court. She is looking at cost of step for certified and non-certified and to add to the base on the salary schedule. NKESC expenditures for next year are still not available, but Mrs. Zeigler expects there will be an increase. Legislators overrode governor's veto on new tax bill. Preliminary enrollment numbers for 2017-2018 and Strategic Plan Goals were reviewed.
