Mrs. Zeigler believes the results from special session does fix the inequality to districts. USD 293 will have no more money than the district has had previously in the General Fund. USD 293 will receive \$107,140 state aid in the LOB therefore this allows the district to lower the requested number of mills which will provide some tax payer relief. Capital Outlay was down \$40,000 this year because of valuation decrease from \$25,000 to \$20,000. District will receive \$36,506 of state aid for Capital Outlay in the 2016-2017 budget year. Remember this fund is for building maintance and improvements. Budget Check Form was reviewed. Auditorium grant application was reviewed by Mrs. Zeigler.
