# **Transportation Report:**

Mrs. Kephart informed the board that Arlan Wolf would like to present on the condition of the school vehicles at the September BOE meeting. An ad was submitted to the newspaper to advertise for a bus driver.

## **Grade School Building Report:**

Completed enrollment, 202 students enrolled in grades pre-school to 6th grade. Various water line leaks repaired throughout the building and a new booster for the kitchen dishwasher has been installed in the grade school. Rich will install windows in the principal and superintendent office doors. Students 1st through 12th grade start school on August 17th. Kindergarteners will start school on August 18th and preschool will begin school on August 21st. All kindergarten families have signed up for a 1/2 hour screening slot on August 17th. An ASQ form will be used for the screenings.

#### Junior-Senior School Building Report:

Mr. Countryman thanked the board of education members for the staff picnic they provided. Enrollment is complete, but student numbers are not complete yet. Have had some local interest in the forensics coach position and Mr. Countryman is looking into one more lead before any decision can be made. Golden Plains Credit Union would like to sell shirts for a Code Red basketball game on January 12th. Sales in the past have been donated back to the school. Mr. Countryman asked for board approval to donate the remaining wrestling mat to the Quinter Youth Wrestling Program. South gym floor has damage from a leak in the roof and a section will need to be cut out and replaced. CHS has donated \$2,500 to improve the Ag shop and greenhouse. Mr. Countryman said he was preparing for the start of the school year and the return of staff and students,

#### All-School Building Report:

New teachers and their mentors attended meetings on August 10th for their mentoring program. New computers were installed and Denton George has reported that the labs in both the GS and HS are ready to go for the start of school. Solar Eclipse glasses ordered off Amazon will not be used by the students for viewing the solar eclipse.
